

Victoria and District Cricket Association Division II Minutes of Captains Meeting Tuesday March 15, 2016; 7pm Fred Maurice Pavilion, Beacon Hill Park, Victoria BC

- 1. Call to order
 - 1.1. Clubs Present: Sticky Wicket, UVIC, Metchosin, Ross Bay, Beagle, Central Saanich, Pigs Trotters, Stonewallers, Spinnakers
 - 1.2. Clubs Not-Present: MCC, Colts, Wicket Maidens, Fulham, Fernwood
- 2. 2016 Schedule handout and playing conditions
 - 2.1. A possible conflict was raised between Spinnakers and Wicket Maidens because their game is on July 1st.
 - 2.2. It was raised that there are 2 open days the Week of June 17th. On the Schedule there is a free day for a make-up game or rescheduling on **Thursday June 23rd**
 - 2.3. Metchosin Rep mentioned that the Colts might struggle to drive out to Metchosin for their game. They agreed that we can change the location to Windsor Park.
- **3.** Team Dues are set at \$550 this season. \$500 goes to the VDCA from each team, the remaining will be for balls, tournaments and awards for the season.
 - 3.1. VDCA requested the Premiership hand over our bank account but for now, we will remain separate and will take the team dues ourselves and disperse the dues to the VDCA
 - 3.2. Team Dues are due by April 22, 2016 or earlier
- 4. Cricket balls for each team
 - 4.1. Executive will be ordering more white balls and some orange ball for trials in the dark
 - 4.2. A mixture of red and white balls will be dispersed to each team with 1 orange ball as a trial
 - 4.3. Teams can use a red ball, but the Captains must decide on this prior to the game
 - 4.4. The home team will supply the game ball and only 1 ball will be used in a game.
- 5. Six aside Odlum Brown Tournament June 18, 2016
 - 5.1. Vice-President mentioned he will be looking for some additional sponsorship for this tournament
- 6. Knockout Cup
 - 6.1. This year's knockout cup will be based on rankings from the season. The cup will be played during the month of August after VISAS & double knockout
 - 6.2. The schedule ends 2nd week of July. There will be 1 week off then we will start the playoffs. Have a break during the VISAS and resume playoffs afterwards.

7. Revise Colts rules/name

- 7.1. Colts wish to be a normal team that will pay dues and have no junior rules
- 7.2. In the Div 1 league, the Colts dissolved and a new club was accepted into the league by the name of the Centurions. They will no longer play under the rules of the Colts. As per our Premiership rules, if a new team wishes to join our league they must apply at the AGM and a decision will be made at the Captains Meeting. No "Centurion" or Colts representative attended the AGM or this Captains Meeting and no formal request was submitted. As we want to promote junior cricket in Victoria, we are keeping the Colts on the schedule and will hope the junior players from this new Div 1 Centurion team will participate in the Premiership League under the mandated rules of the Colts.

8. Other Business

- 8.1. Team Fees:
 - 8.1.1. Must be paid in full by April 22, 2016
 - 8.1.2. Player registration deposit of \$250 must be paid at or before your 1st game
 - **8.1.3.** The President will propose the VDCA change the player registration cost for Premiership players to be \$10 and be recognized as "social" players. For now, the registration cost still remains \$25

8.2. Playing conditions

- **8.2.1.** Treasurer makes a motion to increase the # of stats players to 2. Motion 2nd by the Secretary. 6 yes, 2 no, 1 abstain. Motion passed. It was raised for clarification that even if a junior player (someone born after Sept 1st 1996) is found to be a stats player by our rules, will still count as 1 of the 2 stats players allowed to play in a game
- **8.2.2.** All other conditions accepted unanimously
- 8.3. Clubs purchasing new kit
 - **8.3.1.** Many clubs brought out a possible reimbursement for purchasing kit. It was agreed that the executive will look over the current finances, budget for the 2016 season and will make a decision on the amount they will reimburse.
- 8.4. New Mat for BHP
 - **8.4.1.** The VDCA approached the Premiership Executive asking for \$5000 to help pay for the new mat they had purchased
 - **8.4.2.** The clubs and the executive agreed that we will need the following information before continuing:
 - 8.4.2.1. Total cost of the mat
 - 8.4.2.2. Percent of usage (Div 1 vs Premiership)

- **8.4.2.3.** The breakdown of how our Premiership League dues are spent (\$6500/season)
- 8.5. Volunteering
 - **8.5.1.** The Pavilion Society will be holding a Spring Cleaning/Beacon Hill Pavilion Cleanout on April 2nd and 9th at 10am both days. If you are available, please come out and help support the society who holds us all together!
- 8.6. Advertising
 - **8.6.1.** The VP is accepting ads for the handbook and has raised \$3000 already!
 - **8.6.2.** If any teams have players who own a business, specializes in sports physio/massage this year might be a good year to get an advertisement in the handbook as it is a VISAS year!
- 8.7. Online Scoring Course
 - **8.7.1.** We will send out a link to an online scoring course for any interested scorers out there
